CTC committee creation

We are happy to inform you that the Clinical trial committee (CTC) has been created in June. Applications have been evaluated by Andy Pearson, Pamela Kearns (SIOPE), Julie Park (COG), Angelika Eggert and Cormac Owens. The elected members are Juliet Gray (chair), Lucas Moreno (vice-chair), Thorsten Simon, Mark Gaze, Giuseppe Barone and Shifra Ash.

The general aim of the CTC is to facilitate the opening and to monitor the conduct of SIOOPEN clinical trials

- To overview SIOOPEN clinical trials
- To create and manage a live database of ongoing clinical trials (recruiting, completed, on follow-up, in set up and in planning), accessible in part on the public/members website
- To aim to minimize the delay of opening of clinical trials
- To give a regular feed-back to the EC on the trial progress
- To monitor timelines on publications
- To create/develop/implement/monitor SOPs or policies for clinical trial conduct, so that trials are more operationalized and more efficient

Other key points of the last EC conference call (of 03.07.2020)

EUSA-SIOOPEN Pilot study:

- Memorandum of understanding is in signature
- A conference meeting will be organized by EUSA with the steering committee and the PIs of the participating countries to discuss further steps towards activation

Relapse strategy meeting:

- Is planned by virtual conference for July 20th. Results of the returned questionnaires will be discussed as well as the results of on-going relapse studies (RIST, BEACON etc) and further steps defined

Lorlatinib trial (transatlantic SIOOPEN-COG):

- In active development
- Discussion on-going on potential connection of a Lorlatinib arm to HR2 according to response to induction treatment

Liquid biopsy manager:

Idea to hire a person to manage all sample collections for the HR2 protocol, to manage the data base, to connect with data that are not on the Bioportal.
